## **GLEN RIDGE COMMUNITY POOL MEMBERSHIP AGREEMENT**

Members of the Glen Ridge Community Pool are required to pay in full the total sum for membership (including a one time, non-refundable initiation fee and annual dues). Members are responsible for paying annual dues by March 1<sup>st</sup> of each year. Members who fail to make full payment by the due date will forfeit all rights to their membership. Members are responsible for all other charges including guest fees, which are due and payable when rendered.

All Members agree to comply with the Rules and Regulations now in force and hereafter changed or adopted by the Executive Committee. A Copy of the Rules and Regulations is sent to new members once payment is received.

Members recognize that use of the Pool facility and equipment entails certain risks of bodily harm. The undersigned member assumes any and all risk and responsibility when using the pool and any of its equipment. The Member assumes the risk for all members of his/her family. Guest of the Member assumes their own risk.

All member applicants acknowledge that this agreement constitutes the entire understanding between the parties (member and pool) and that no other understanding or agreement exists between them; and that no representations other than those herein have been made by anyone to the undersigned to induce them to enter into this agreement, which shall not be changed or terminated orally.

Members agree not to hold the Glen Ridge Community Pool liable for any loss of cash or loss of personal property.

The Executive Committee reserves the absolute right to suspend or terminal all membership privileges when, in its opinion, a member's behavior is judged to have compromised the safety or enjoyment of other Pool Members.
